The resultant contract awarded, if any, will be awarded on an all or non basis as a Fixed price (IDIQ) Contract with Cost Reimbursement provisions. The Contract performance period will be a three-year base period with the potential of an additional two-year option period. This acquisition is unrestricted. This solicitation will not result in a contract if Government performance is determined to be more advantageous in accordance with the OMB Circular A-76 procedures. Hard copies of the RFP will not be available. The RFP closing date is currently scheduled for January 23, 2004. The Site Visit and Pre-proposal Conference will be conducted on Sunday, October 26, 2003 and Monday, October 27, 2003 at 8:00 a.m. with registration beginning at 7:30 a.m. for both days.
